CALCULATING PPD RATE

In determining PPD

If TTD is > 205.35 then PPD = 75% of TTD rate

If TTD is < 205.35 then PPD = 154.00 maximum

MAXIMUM WEEKLY BENEFITS PAYABLE BY
THE EMPLOYER OR THEIR INSURANCE CARRIER

Before December 31, 2007:

For injuries occurring on or after March 1, 1981 or on or before December 31, 2007, the maximum weekly benefit payable by the employer or their insurance carrier is \$75,000.00.

After January 1, 2008:

For injuries occurring on or after January 1, 2008, the maximum weekly benefit payable by the employer or their insurance carrier will be (325) times the maximum total disability rate.

For example: The maximum payable in 2008 is \$522.00 x 325, or \$169,650.00. The maximum payable in 2009 is \$550.00 x 325, or \$178,750.00. The maximum payable in 2010 is \$562.00 x 325, or \$182,650.00.

Maximum Benefits Payable:

2007:	\$ 75,000.00
2008:	\$169,650.00
2009:	\$178,750.00
2010:	\$182,650.00
2011:	\$186,875.00

Note: In certain cases, the Arkansas Death and Permanent Total Disability Bank Fund is responsible for payments beyond the maximum owed by the employer or their insurance carrier.
